**PLAINTIFFS' RESPONSE TO THE UNITED STATES' MOTION FOR AN
EXTENSION OF TIME TO FILE A REPLY BRIEF [ECF 197]**

On June 6, 2022, the United States moved “to extend the deadline for the parties to file reply briefs in support of their respective motions for summary judgment.” ECF 197 at 1. Plaintiffs respond as follows:

1. Plaintiffs do not oppose the United States' request for an extension of time within which to file reply briefs.
2. Plaintiffs understand that the United States, in its reply brief, intends to make new arguments relating to the amount of the PTIN user fee imposed by the IRS in Fiscal Years 2011-13.
3. If the motion for extension is granted, plaintiffs request that they be allowed to file a surreply of up to 15 pages by no later than July 22, 2022, addressing any new arguments raised by the United States in its reply.
